Balanced Budget Adopted

The WBMD Board amended the 2021 Budget to reflect progress on removing deadfall from the Eagle's Nest Wilderness (ENW) adjacent to our western boundary. Previous newsletters have discussed what appears to be a new willingness on the part of the US Forest Service to work with us on removing deadfall. This work takes top priority on the Ranch, so the 2021 amended budget postpones non-essential projects to free up funding for the work in the ENW. Specifically, money set aside for additional monoliths at street corners and for postal boxes on the Ranch will be deferred, bringing the forecast spending into balance with forecast revenues. We are also pursuing \$79,000 in matching grants from Summit County to offset what are expected to be substantial expenditures related to our fire suppression system and the ENW project. For reference, our General Fund spending for 2021-22 is forecast to total \$330,000.

And speaking of fire mitigation, the Fire Committee is building the strongest possible case for funding help in the ENW. Federal law mandates hand tools for removing the deadfall, which will likely drive the cost up a lot. The

US Forest service will "own the project" but Ruby Ranch may be asked to pay all or a significant part of the costs; hence we are building the strongest case we can for government funding help; county, state and federal.

As part of this case, we asked Summit County for information on Ruby Ranch owner participation in the County's free chipping program. The program has been in existence for seven years. During that time, about 3/4's of Ruby Ranch parcels have participated with the average being 2.5 times, contributing about six piles per time. Even allowing for some inflation in the numbers, that is outstanding community-wide participation and helps us make the case that "Ruby Ranch is doing its part re: fire mitigation."

We have pulled together a chart showing WBMD spending on various water and fire related projects and it is impressive: waterline upgrades, fire hydrants, interconnect valves, an emergency exit bridge and removal of deadfall from community property. David Radlauer and Lisa Lewis are working on a survey of Ranch owners re: what they have done privately to protect against fires. We are confident the "final package" will be very impressive!

Ruby Ranch Website Update

Our neighbor, Ashley Johnson, is taking a fresh look at our rubyranch.com website to bring it up to date and make it more useful and more frequently visited by the Ruby Ranch community. Ashley is exploring how we might add live video footage and weather information, especially for our non-resident owners.
